## Regulations for renting kayaks

- 1. Equipment is rented on a fee basis in accordance with the price list or individual arrangements with the owner of the company Ad-Group Adam Rybarczyk.
- 2. Rental does not organize canoeing rallies but only provides and rents equipment. Kayaking trips are organized by participants on their own and at their own responsibility.
- 3. To rent the equipment you must show an identity document with a photo (ID card, passport, driver's license). In the case when issuing the equipment will consider the customer as unreliable, without justification may refuse to rent the equipment. Also, persons under the influence of alcohol or other intoxicants, as well as minors will not be served.
- 4. Equipment rental is equivalent to acceptance of the rules.
- 5. The Lessee is obliged to check the condition of the rented equipment in terms of its quality and quantity and to submit any comments to the lender. The Lessee must use the safety vests in accordance with their purpose and is fully responsible for observing the safety rules.
- 6. The equipment returned to the Rental should be in a condition allowing it to be rented again.
- 7. Collection and return of the equipment takes place at the location previously agreed between the Lender and the Rental.
- 8. The equipment may be reserved under the conditions agreed upon with the Lending Library.
- 9. For equipment not returned on time, the Rental may charge an additional fee of 100% of the daily rental fee. 10. minors are allowed to swim in the water.
- 10. Minors may only sail under the supervision of adults who are fully responsible for them, their behaviour and any possible damage.
- 11. The Rental accepts no responsibility for the behaviour of participants on the canoeing trip and in particular for any damages they may cause to other persons or companies.
- 12. The Rental does not take any responsibility for accidents, loss of health or death of the participants.
- 13. The Rental is not responsible for any damages to the vehicles left on its premises, especially for theft, damage, devastation, including damages caused by forces of nature.
- 14. Earlier than agreed date, place and time of the end of the trip must be accepted by the Rental and can be realized only on its terms.
- 15. Any person violating the regulations of the rental service will be obliged to terminate the trip with the rented equipment regardless of the time of stay on the water without any refund.
- 16. The Lessee is obliged to follow the instructions given by the Rental and the authorized services.
- 17. In case of loss, theft or irreversible damage to the equipment the Lessee will return the equivalent of 100% of the market price regardless of the degree of its depreciation.
- 18. All disputes shall be settled amicably in the first place. In case of lack of agreement, disputes shall be settled by the court having jurisdiction over the Rental.
